# The importance of alliances between social and housing sector to promote housing first and end homelessness 11:30-13:00

# Seminar

One out of five people in Austria live in limited-profit housing. The sector provides affordable homes for many. Lately, it has become a close ally to Austria's homelessness service sector. "housing first austria – arriving home", a project initiated by BAWO, ends homelessness for over 2.000 people and establishes a model bound to eradicate homelessness in the country. It closely collaborates with limited-profit housing associations on all levels in order to make homes accessible where needed. And: Government funding provides a means for people affected by poverty to break down financial barriers to this affordable housing stock, making the housing market more inclusive for all.

Emine Özkan (BAWO) and Gerlinde Gutheil-Knopp-Kirchwald (GBV) give an overview on Austria's large limited-profit housing sector and the history and intricacies of "housing first austria's" cross-sectoral collaboration on ending homelessness.

Emine Özkan is project manager of housing first austria – arriving home at BAWO – housing for all.

Gerlinde Gutheil-Knopp-Kirchwald is head of the department for housing economics and research at the Austrian Federation of Limited-Profit Housing Associations (GBV) in Vienna, Austria. She holds a master's degree in urban and regional planning and a PhD in housing economics.

# Using AI to Improve Homelessness Services 11:30-12:30

### In conversation with

This talk will explore the use of artificial intelligence (AI) and machine learning to improve the services provided to people who experience homelessness. It will begin by describing how AI can be used to support, not replace, frontline human staff in the housing and homelessness system of care. Practical guidelines will be provided regarding how agencies should combine their data with machine learning to minimise bias and maximise how well predictions fit the people accessing a particular service. This discussion will touch on important ethical considerations that include the representation of people in data and the accessibility of the data tools themselves. The discussion of tool accessibility will include how best to implement AI in a not-for-profit setting with limited access to advanced information technology (IT) infrastructure and expertise. Two case studies will be discussed in detail. The first involves using Al as an early warning system to identify people at risk and provide

them with supports before or soon after they enter homelessness. The second case study discusses using AI as a way to link fragmented data sets in order to better understand how one person interacts with many agencies within a system of care.

# CANCERLESS Project: Using the 'Health Navigation' Model to Fight Cancer (and Health) Inequalities 11:30-12:15

The CANCERLESS project is an EU-funded research initiative aiming to tackle barriers to access cancer prevention faced by people experiencing homelessness (PEH). This spotlight on session will focus on the unique Health Navigation Model that has been co-developed, implemented and evaluated in CANCERLESS, which aims to bridge the gap in healthcare access and quality for PEH. Participants will learn how this model facilitates early cancer detection and prevention by providing tailored, person-centred care. The workshop will also discuss strategies to adapt and scale this model to effectively address health inequalities for PEH in different regions. Emphasizing hands-on interaction and case studies, the session will be an informative platform for health and social care professionals as well as policy makers, encouraging collaborative efforts to extend the reach of the Health Navigator Model to this vulnerable population.

Across Europe we are seeing disturbing attempts to criminalise homelessness. These refer to how housing is funded and provided and to what purpose; how it is maintained, and by whom; how and under which conditions access is organized; how it can be appropriated by its residents. Starting with an introduction to social housing in Vienna, we will use this interactive workshop to exchange and compare our experience and views on social housing and develop arguments on housing quality which are so needed in current policy debates.

# Imprisonment and Homelessness – From Research to Practice 14:30-15:15

# Spotlight On

Combining research and practice, this session will explore findings from the latest Comparative Study by the European Observatory on Homelessness (EOH), examining the link between imprisonment and homelessness in the EU, followed by practical insights from the Finnish Foundation for supporting ex-offenders, RETS –Life without crime.

The EOH study explores the existing evidence on the relationship between homelessness and imprisonment and current policy and practice in trying to prevent homelessness on leaving prison in 13 EU Member States and draws comparisons with two further European countries, the United Kingdom, and Norway. A general overview of insights into the effectiveness of current strategies and the need for coordinated policy implementation will be discussed.

Following this, we will zoom in on the work of RETS, Finland, who have been presenting solutions to the homelessness of prison leavers for over 20 years. Through national housing guidance and networking, they spread basic knowledge and encourage cooperation throughout the social system. RETS offers scattered, HF-based supported housing in the Helsinki Metropolitan area.

For over 30 years de Tussenvoorziening has provided low-treshold facilities, debt counselling, and housing solutions for people in a marginalised or homeless situation.

The main goal of the organisation is to build sustainable housing solutions. Over the last few years, hundreds of people have found their home in a welcoming neighbourhood in a Mixed Living project. Not a staircase model, but a home. Providing socialisation, inclusion, and normal living in the neighbourhood. The key to the approach is to facilitate neighbours in building their own welcoming society and at the same time providing durable housing first solutions for people who are homeless.

# Support For Migrants with Precarious Status 15:30-16:15

# Spotlight on

Regardless of status, country of origin, or country of residence, navigating the migration and housing system without support can lead already vulnerable migrants to deeper levels of destitution and alienation. This session shines the spotlight on two services, from Belgium and Germany, which both help migrants with precarious status navigate their situation, through guidance and counselling.

From Belgium we will look at the shelter 'Opvang en Oriëntatie mensen zonder wettig verblijf'. Here they offer guidance for people with irregular status. They provide shelter for 18 people (mostly men) and give them legal and perspective quidance. The focus of the project is gaining regular status, by helping people to provide documents or discussing voluntary return and other possibilities. Els Goossens of CAW Oost-Vlaanderen will present you with facts and figures from the first two years of the project and talk about how they have worked together with

migration services and the local government.

From Germany, we will look at the pioneering approaches of "MOCT – Berliner Brücke zur Teilhabe" at the interface between homelessness assistance and migration. We will highlight the challenges faced by homeless EU citizens in Berlin and present our action strategies aimed at improving their living conditions. Our main focus is on accommodation, social counselling and issues related to integration into the labour market. We explain how we can take effective action against discrimination and how we can achieve a stabilization of the living situation through intensive counselling, practice-oriented workshops in the help system and cooperation with a lawyer.
